DEFINITION:

1. In this Bye-Laws, unless contended otherwise, the following words and expressions shall mean as under :-

- (a) 'Society' means Mukhtar Ahmad Educational Society Mohall Dhammal, Gorakhpur.
- (b) 'Chairman' means Chairman of the Society.
- (c) 'Vice Chairman' means Vice Chairman of the Society.
- (d) 'Secretary' means Secretary of the Society.
- (e) 'Joint Secretary' means Joint Secretary of the Society.
- (f) 'Fellow' means Fellow of the Society.
- (g) 'General Body' means the General Body of the Society.
- (h) 'Committee' means the Committee of Management of the Institution.
- (i) 'President' means President of the Committee.
- (j) 'Vice President' means Vice President of the Committee.
- (k) 'Manager' means Manager of the Committee.
- (l) 'Asst. Manager' means Asst. Manager of the Committee.
- (m) 'Member' means Member of the Committee.

CONSTITUTION OF THE SOCIETY:

- 2. The General Body of the Society shall consist of all the Fellows.
- 3. Any Muslim competent to contract and on payment of Rs. 5000/- to the Secretary and approved by the General Body shall be Fellow of the Society. How ever in no case the number of fellows shall exceed FIFTEEN.

4. Person desirous of being selected as Fellow of the Society shall have to apply to the Secretary in writing along with a sum of Rs. 5000/- The Secretary shall place the application before the General Body for approval, and on being accorded approval by the General Body, the applicant shall become a Fellow of the Society. The approval of Fellow will be the sole discretion of the General Body and its decision in that regard shall be final and can not be called in question in court of law or otherwise. In case, the General Body does not approve the Fellowship, it will not be bound to assign any reason and the deposit of Rs. 5000/- shall be refunded to the applicant.

**MANAGEMENT:**

5. For the proper and effective administration of the affairs of the Society and the Institution there shall be the following bodies:-

- (a) General Body
- (b) Committee of Management

6. **OFFICE BEARERS OF THE GENERAL BODY:**

The following shall be the office bearers :

- (i) Chairman
- (ii) Vice-Chairman
- (iii) Secretary
- (iv) Joint Secretary



**COMMITTEE:**

(a) The office bearers mentioned in rules 6 shall also be the office bearer of the Committee of Management. But while acting for the Committee, instead of Chairman, Vice-chairman, Secretary and Joint Secretary, they will respectively be called:

- (i) President
- (ii) Vice President
- (iii) Manager
- (iv) Asst. Manager

8. POWERS OF THE GENERAL BODY:

- (a) To select Fellows in case of the vacancy.
- (b) To elect office bearers and members of the Committee of Management other than ex-officio members.
- (c) To amend Memorandum of Association and the Bye laws except clauses affecting the Minority Character of the Society and the Institution as well as Rule of the Bye-laws.
- (d) To pass yearly budget.
- (e) To frame rules for the election if and when necessary.
- (f) To appoint Sub Committee if and when required
- (g) To accord approval with regard to the Banks and Post Office where the accounts of the Society are to be opened.
- (h) To give approval for purchase acquire or obtain by way of lease or otherwise any property for the Society.
- (i) To give approval for the sale, transfer, lease or mortgage of any property of the Society.
- (j) To consider the Annual Report.
- (k) To obtain Loan, Bank Guarantee or Cash Credit Limit from Bank or

any other financial Institute with the approval of the General body.

(l) The Secretary shall be empowered to sign all the deeds and other related documents for the purposes mention in aforesaid clause (k) or jointly with other office bearers of the Society duly authorized by the General Body, as the case may be.

9. The Committee of Management shall function in accordance with the Scheme of Administration of the Institutions run by the Society

10. OFFICE BEARERS AND MEMBERS of the Committee of the Management shall continue as such up to a period of five year from the date of the Registration after the expiry of the aforesaid period, the election will be held.

11. TERM

The term of the office bearers of the General Body and the Committee shall be Five years from the date of election. The office bearers and members shall be deemed to have continued till their successors are elected.

12. VACANCY

The following shall cause vacancy:

1. Death
2. Undischarged insolvent
3. Insanity
4. Resignation
5. Removal

13. RESIGNATION

If any Fellow of the Society resigns in writing, his seat shall thereupon become vacant. The resignation shall be delivered to the Secretary.

14. REMOVAL:

A Fellow, or office bearer or member may be removed by a majority of 2/3 present in the meeting of the General Body on any of the following grounds:

(i) That he has absented himself from three consecutive meetings of the General Body without any just cause.

(ii) That he has incurred any of the disqualifications mentioned in Rule 15.

(iii) That if in the opinion of the General Body his continuance is considered prejudicial to the interest of the Society of the Institution.

**15. DIS-QUALIFICATIONS:**

A person, notwithstanding that he is eligible, shall be disqualified for continuing as a Fellow of the Society if he:

Is a dismissed employee of a local authority, the Central or State Government and is debarred from re-employment.

Is debarred from practicing as a legal or Medical practitioner by order of any competent authority.

Has been convicted for an offence of moral turpitude.

**16. CASUAL VACANCIES:**

Any casual vacancy among the office bearers or members of the Committee shall be filled in by the General Body for the un expired period only.

**17. REMUNERATION:**

No Fellow, office bearer or Member shall be granted any remuneration by the Society.

**18. MEETINGS:**

1. Ordinary meeting.

2. Emergent meeting.

3. Requisition meeting.

4. Annual meeting

5. Adjourned meeting.

The General Body shall meet at least thrice in a year.

(c) One-Third Fellows may send requisition notice for calling a meeting of the General Body to the Secretary for any specific purpose. The Secretary shall there upon call a meeting in terms of the requisition notice. In the event of his failure the chairman shall convene a meeting through written notice on the his signature.

(d) There shall be an Annual meeting of the General Body on the second Sunday June of every year.

**19. QUORUM:**

It shall be necessary for the transaction of business that not less than one third of the total number of the General Body are present. Provided that, when it is necessary to postpone the meeting for want of the prescribed quorum or otherwise, the Chairman shall adjourn the meeting to another date.

- a) No quorum is needed for an adjourned meeting.
- b) At an adjourned meeting no business shall be transacted other than business left unfinished.

**20. PROCEDURE FOR CONDUCTING THE MEETING:**

- (i) If at a meeting of the Genera Body neither the Chairman nor the Vice Chairman is present the Fellows present shall elect from among themselves one to preside the meeting and such Chairman shall perform all the duties and exercise all the powers of the Chairman.
- (ii) The minutes of the last meeting shall be read and confirmed at each meeting as the first item of its business. Any objection as to the correctness of the minutes may be raised only by the person who was present in the meeting in question and shall be decided by the person presiding, after hearing the views of those present at the said meeting.
- (iii) Any matter not included in the Agenda may be taken up for consideration with the permission of the person presiding over the meeting.

**21. DECISION BY VOTE:**

All questions which may come before a meeting shall be decided by a majority of the votes.

In case of an equality of votes the Chairman of the meeting shall have a casting vote.

**22. NOTICE:**

- a) A notice to attend the meeting shall be signed and issued by the Secretary.
- b) A notice to attend a meeting shall specify every motion or proposition to be brought forward at the meeting and shall state generally and other business to be transacted there at.
- c) Every notice to attend shall state the place.
- d) Three days clear notice is necessary for an Emergent meeting.
- e) Four days clear notice is necessary in case of an ordinary meeting.
- f) Three days clear notice is necessary for requisition meeting.
- g) Seven days clear notice is necessary for Annual meeting.
- h) Two days clear notice is necessary for adjourned meeting.

**23. SERVICE:**

Notice may be served either personally or through post. The notice sent under certificate of posting shall be treated as due service, except as provided under Rule 18 (c).

**24. POWER AND DUTIES OF THE CHAIRMAN:**

- a) To preside over the meeting of the General Body.
- b) To call a requisition meeting in case the Secretary fails to call the meeting.
- c) To regulate the proceeding of the General Body.
- d) To have the casting vote in case of equality besides his own.
- e) To see that the Memorandum of Association and the Bye-Laws are faithfully carried out.
- f) To exercise such other powers and to perform such other duties as may be conferred or imposed upon him by any law or rule enforce from time to time.
- g) To delegate in writing in his discretion any of his powers or duties to the Vice Chairman.

**25. VICE CHAIRMAN:**

- a) To act as Chairman in the absence of the Chairman.
- b) To exercise and perform all such powers and duties as may be delegated to him by the Chairman in writing.

**26. SECRETARY:**

- a) The Secretary shall be the sole authority for carrying on all correspondence on behalf of the Society.
- b) The Secretary shall maintain proper accounts of the Society.
- c) To arrange for annual audit.
- d) To receive gifts, grants, donations, contributions, subscriptions and rent and to issue proper receipts for the same.
- e) To approve and sanction all payments.
- f) To operate Bank and post office accounts approved by the General Body.
- g) To sign all agreement and contracts etc. relating to immovable property.

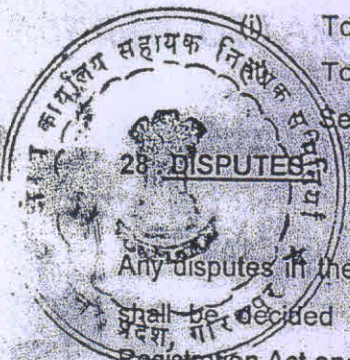

- k) All the properties movable and immovable shall be in the custody of the Secretary who shall be responsible for the proper maintenance of the same.
- l) To exercise such other powers and perform such other duties as may be conferred or imposed upon him by the Committee or General Body or by any rule, regulations or any law enforce from time to time.
- m) The Secretary may delegate any of his powers to the joint Secretary in writing

**27. JOINT SECRETARY:**

To act as Secretary in the absence of Secretary.  
 To perform all such powers and discharge all such duties of the Secretary as may be delegated to him by the Secretary.



Any disputes in the election of the Society or relating the right of Management shall be decided in accordance with the provisions of the U.P. Societies Registration Act and the Rules framed there under.

**29. GENERAL:**

The principal of the College shall be a Muslim.

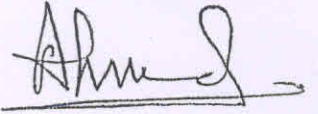
