The school is required to upload Mandatory disclosure as per annexure - IX in the home page under distinct icon on the school website for easy accessibility by public in compliance to Board's circular no. 09 dated 21-05-2021. 3. separate toilets for CSWN are not seen in the video. The school must provide for the same at every floor, both for boys and girls. 4. In one of the toilets, cubicles have rusted door panels, which may adversely impact the children's health. The same may be repainted/replaced. 5. The school should construct ramps at the entrance(s) of the school building and inside to allow easy access to upper floors by CSWN. 6.. The Computer lab needs to be organised as per Board guidelines. 7. The Library needs to be properly stocked as per guidelines. 8. The playground needs to be developed properly and more facilities for outdoor games should be created. 9. The school is required to conduct training programme for its teachers and maintain the record. 10. The school is still under construction, hence appropriate measures should be taken to ensure safety of students. 11. The school is required to renew all the mandatory certificates from time to time. 12. The school is directed not to remove videography link in future. 13. Compliance of the points no. 2 to 10 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.
